

Smart Tech Tools PESTlogics: Farm-A-Syst

What is Farm-A-Syst?

Farm-A-Syst, or FAS, is a self-evaluation program that allows farmers and/or their advisors to assess their farming practices with respect to water resources protection. This national program was adopted for Pennsylvania in the 1990's as a series of paper worksheets to promote awareness about site

conditions that degrade water resources. Today, selected FAS topics have been adapted to a digital format and combined with mapping technology in PESTlogics to make farm assessments easy and readily accessible.

How do I get started? You can assess your farm in just a few easy steps. All you need are the FAS digital forms available in PESTlogics on a mobile tablet or smart phone to get started:

- 1. First, go to <u>ipm.pestlogics.com</u> to register for a PESTlogics account, and then log into your account.
- 2. Next, define your management areas on the digital maps, such as a field, forested block, or barnyard.
- Then, select the worksheet of interest for the selected management area, and complete the assessment with scoring categories: Best, Great, Fair, and Poor.
- 4. If desired, take pictures and record notes of specific challenges and opportunities. Hit SAVE.

Now you have a digital record of your worksheets. The performance ranking will give you an understanding of conditions on your farm and their impacts on water resources, while also targeting areas for improvement. **Contact the** *Center for Water Quality Excellence* to get started using Farm-A-Syst by following the steps on the back of this page.
