Funding Recipient Responsibilities

The recipient of funds must provide the following to receive funds:

- Provide the signed **Landowner Agreement** between the landowner of the site where the tree planting is to be installed and the partner organization;
- Provide a final planting plan for the site, approved by WAY.
- Agree to install ____ acres of riparian forest buffer on project named:_____;
- Agree to manage all aspects of the installation of the tree planting;
- **Complete and submit a post-planting report within 60 days of planting date to WAY**, that includes a final map of planted acres, a stem count, and one to three site reference photos that reflect the originally approved project application;
- Ensure riparian buffer maintenance is upheld for the duration of the six-year Landowner Agreement.

Watershed Alliance of York's Responsibilities

As the administrator of the funding, WAY will provide a pre-planting **award of \$6,000 per acre of unique riparian forest buffer to the implementation partner** upon receipt of this signed contract.
